Once a rider canters in a show they may not go back to this division, but must go on to divisions that require a canter. Entries to be shown at the walk and trot going both directions. Will be judged on the basis of fundamentals of equitation. *CHAMPIONSHIP AND RESERVE RIBBONS AWARDED*

Limited to riders 12 years and under who have never competed over fences exceeding 18" in a recognized show. Riders showing in this division may not compete in any other recognized division or recognized class in a show with fences exceeding 18" with the exception of pleasure and pet-type pony classes. Cross-rail fences not to exceed 18". *CHAMPIONSHIP AND RESERVE AWARDED*

CHSA Recognized

Open to riders 18 years of age and over who are in their first years of showing. Riders competing in the Long Stirrup Division are not eligible for other classes at the same show except Pleasure and Trail Classes. If entries warrant, this division may be split into riders 18 - 30 years of age, and Over 30. A person winning this award is eligible for this division in the future.

At the same show, riders may not cross enter into Children's Equitation, Children's Pony Hunter, Pony Hunters, any Medal classes that exceed 2' or any class where fences exceed 2'6". DERBY CLASSES –HUNT AND GO FORMAT

NEHC, CHJA, CHSA Recognized

Class 301 and 302 open to amateur adults and junior riders to be shown over a course of ten fences at 2'-2'3" with height not to exceed 2'6" for class 301 and 2'6" for class 303 with higher options. Class 303 is open to all riders. Class specs same as classes 301 and 302 with fence height being 2'9" with higher options.

The first round judged on performance, hunter pace and style, quality and substance, and movement. The course should include at least one in and out, one bending line and one unrelated distance. The obstacles are to simulate those found in a hunt field. Natural obstacles may be used. All riders will be invited back for the second round, a handy hunter round of six to eight fences which may include at least 2 of the following: trot jump, tight turn option, clever option for jump approach, halt and/or back and a walk jump. To be judged on style, brilliance, and handiness. Judges will adhere to USHJA Hunter Derby rules for scoring. The score will be a total of the two rounds. The exhibitor will be allowed to ride the first round, leave the ring, and then return for the handy round.

Both rounds can be ridden back to back. To fill a class, at least four horses must compete.

MEDAL AND CLASSICS (\$30 PER CLASS UNLESS OTHERWISE STATED)

CHJA MEDAL CLASSES

Riders must be current members of CHJA. The class consists of 2 phases- fences and flat – each counting for 50%. At least four riders must complete both phases, same horse/rider combination for both phase. May enter only one Medal class per show. Judge may require additional testing, using current USA Eq. tests 1-8 for Children and Pony Medal, test 1-19 for Junior and Adult Medals.

All contestants are required to perform over at least eight fences not exceeding 3'3". One or more individual tests of the top four contestants may be requested at the judge's discretion (USEF tests 1-19). To fill a class at least four competitors must complete the course. One win required to qualify for the finals.

212. NEHC ADULT AMATEUR HUNTER SEAT MEDAL: Open to Adult Amateur Members of the NEHC. All contestants are required to perform over at least 8 fences not to exceed 3'. One or more individual tests of the top four contestants may be requested at the judge's discretion (USEF current tests 1-19). To fill a class, at least four competitors must complete the course.

Open to all horses and riders. At the same show, horse/rider combinations are not eligible to compete in any other Jumper classes where fences exceed 3'0". Fence height will be 2'-2'3". No combinations. CHAMPIONSHIP AND RESERVE AWARDED

Low Training Jumper - CHJA, CHSA recognized

Open to all horses and riders. Fences 2'6" – 2'9". Horse and rider combinations are not eligible to compete in any other jumper classes at the same horse show whose specifications exceed 3'6". CHAMPIONSHIP AND RESERVE AWARDED

114,115,116 – LOW TRAINING JUMPER 2'6" – 2'9"

LOW CHILD/ADULT JUMPER – CHJA, CHSA recognized

To be ridden by Exhibitors who have not reached their 18th birthday by December 1 of the current competition year or adult amateurs. All exhibitors must be amateurs in accordance with GR1306 Fence heights to be set at 3'-3'3" Riders may not compete in any other class at the same competition where fences exceed 1.15m (3'9"). CHAMPIONSHIP AND RESERVE AWARDED
117, 118, 119 – CHILD/ADULT JUMPER –Fences3'-3'3"

WELL A WAY FARM RULES AND REGULATIONS

1. Entries close 5 pm the day before show date. Post entries accepted the day of the show at an additional \$20.00 per entry form.
2. The Show Committee reserves the right to cancel, vary or combine, any classes if in its judgment, the entries so indicate. If the area of the courtesy circle is to be restricted by a mandatory line, the line will be indicated on the diagram and a corresponding barrier will be erected on the course.
3. No entry fee will be returned because of withdrawal of a contestant after closing of entries except where an entry, through injury or illness, is unable to exhibit. In such cases, all unused entry fees will be returned upon receipt of a veterinarian certificate.
4. Every class offered herein which is recognized by the USHJA, PHA, CHJA, CHSA and/or NEHC will be conducted and judged in accordance with the current USHJA, PHA, CHJA, CHSA and/or NEHC rules. In order to compete for USHJA, PHA, CHJA, CHSA and/or NEHC annual horse awards, the owner of the horse or pony must be a member of the USHJA, PHA, CHJA, CHSA and/or NEHC and the horse or pony must be registered with the CHJA, CHSA and/or NEHC. In order to compete in CHJA and NEHC Medal classes, riders must be members of those respective organizations..
5. New England Horseman's Council Rules shall supersede any State Rules for NEHC points to count. All specifications not covered in these regulations shall be in accordance with Rules of the USEF in which NEHC is an affiliate member. At any show affiliated with the USEF, the rules of that organization shall prevail over these Regulations.
6. To be eligible for stake classes, horses must have competed in a least one other class over fences in that division.
7. Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. *The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation.* Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.
8. Well A Way Farm Stables, LLC. And will in no way be responsible for any damage that may occur and it shall be a condition of every entry that each exhibitor shall hold The Well A Way Farm Stables, LLC., and The Well A Way Farm Show Committee harmless for any loss or accident which may occur. Should any questions or disputes arise, it shall be referred to the Show Committee whose decision shall be final.
8. The prize list reflects the current USEF rule changes. Class descriptions are no longer required as they are already printed in the USEF Rule Book. It is felt that the exhibitor, as well as the management, should be familiar with the USEF rules. If you are not a member and have any questions concerning this prize list, please phone for clarification. Classes not covered in the USEF Rule Book will be conducted under USHJA, PHA, CHJA,

CHSA and/or NEHC Rules. Class descriptions of CHJA classes, as well as CHJA membership applications, will be available at the secretary's office.

9. The Committee reserves the right to change the location of classes and to alter courses and/or fences, or to change the show schedule as it seems necessary.
10. Prize money: Will be applied towards entry fees. If prize money is not applied, and the error is detected after the show, then that entry shall receive a credit at the next Well A Way Farm Horse Show they attend. The Horse Show will not stop payment or duplicate checks for lost prize money.
11. All classes will be judged on performance and soundness unless other wise noted.
12. Jumping orders of all classes will be established according to USEF rules.
13. Hunter Championship and Reserve Ribbons to be awarded to two of the four horses scoring the most points over fences. Only those four horses will receive full points for the Under Saddle Class.

Every class offered herein which is recognized by the CHJA, CHSA, NEHC and M&S League and will be conducted and judged in accordance with the current CHJA, CHSA, NEHC Rules. To show in CHJA and NEHC Medal classes, riders MUST be members. In order to compete for CHJA, CHSA, NEHC annual year-end awards, the owner of the horse or pony must be a member of the CHJA and the horse or pony must be registered with the CHJA, CHSA, NEHC. A copy of the CHJA Rule Book, class specifications, Medal class specifications, and membership applications are available at the show secretary's office and at www.chja.net, chsaonline.com, nehc.info and hitsshows.com.

By entering a Federation-licensed Competition and signing this entry blank as the Owner, Lessee, Trainer, Manager, Agent, Coach, Driver, Rider, Handler, Vaultor or Longeur and on behalf of myself and my principals, representatives, employees and agents, I agree that I am subject to the Bylaws and Rules of CHJA, CHSA, NEHC and M& S League and the local rules of the Competition. I agree to be bound by the Bylaws and Rules of the Federation and of the competition. I will accept as final the decision of the Hearing Committee on any question arising under the Rules, and agree to release and hold harmless the Competition, the Federation, their officials, directors and employees for any action taken under the Rules. I represent that I am eligible to enter and/or participate under the Rules, and every horse I am entering is eligible as entered. I also agree that as a condition of and in consideration of acceptance of entry, the Federation and/or the Competition may use or assign photographs, videos, audios, cable-casts, **broadcasts, internet, film, new media** or other likenesses of me and my horse taken during the course of the Competition for the promotion, coverage or benefit of the Competition, sport, or the Federation. Those likenesses shall not be used to advertise a product and they may not be used in such a way as to jeopardize amateur status. I hereby expressly and irrevocably waive and release any rights in connection with such use, including any claim to compensation, invasion of privacy, right of publicity, or to misappropriation. The construction and application of Federation rules are governed by the laws of the State of New York, and any action instituted against the Federation must be filed in New York State. See GR908.4.
